Investment Objective and Strategy

The Fund seeks to provide investors maximum current income while maintaining the highest degree of safety and liquidity. The Fund normally invests at least 80% of its assets in U.S. government securities with maturities of 397 days or less and are determined to present minimal credit risk. The Fund intends to qualify as a government money market fund and, accordingly, is required to invest at least 99.5% of its total assets in cash, securities issued or guaranteed as to principal and interest by the United States, its agencies repurchase instrumentalities and/or agreements fully collaterized by cash or such U.S. government securities.


